# I What are we doing?

Swiss Disc Golf Association, Buchholzstrasse 76, 3713 Reichenbach im Kandertal, operates the website https://www.discgolf.ch (hereinafter referred to as "we"). On this website you can consume information about the sport and our association.

The protection of your personal data is very important to us. In this privacy policy, we inform you transparently and comprehensibly about what data we collect via our website and how we use it immediately.

## II What do we inform about?

- What data is collected on www.discgolf.ch;
- Under what circumstances we process your data and for what purpose;
- How long we store your data;
- When disclosure to third parties is permitted;
- How we process your data ("individual data processing operations");
- When and how you can object to data processing;
- What rights you have and how you can assert them.

## III Definitions of terms

## 1) What are personal data?

Personal data (hereinafter also referred to as "personal data") is all information that relates to an identified or identifiable natural person. This includes, for example, name, address, date of birth, e-mail address or telephone number. Personal data also includes data about personal preferences such as leisure activities or memberships.

# 2) What is particularly sensitive personal data?

Data on religious, ideological, political or trade union views or activities; data on health and, where applicable, information on administrative or criminal prosecutions and sanctions as well as data on social assistance measures are considered particularly sensitive personal data. Where necessary and appropriate, we may request and process particularly sensitive personal data. In this case, their processing is subject to stricter confidentiality.

# 3) What is the processing of personal data?

Processing is any handling of personal data, regardless of the means and procedures used, in particular the procurement, storage, retention, use, modification, disclosure, archiving, deletion or destruction of data.

## 4) What is the disclosure of personal data?

This is the transmission or disclosure of personal data, e.g. publication or disclosure to a third party.

# IV What data do we collect from you and from whom do we receive this data?

First and foremost, we process personal data that you transmit to us or that we collect when operating our website. We may also receive personal data about you from third parties. This may include the following categories:

- Personal master data (name, address, date of birth, etc.);
- Contact data (cell phone number, e-mail address, etc.);
- Financial data (e.g. account details);
- Online identifiers (e.g. cookie identifiers, IP addresses);
- Location and traffic data:
- Sound and image recordings

## 1) Under what conditions do we process your data?

We process your data in good faith and in accordance with the purposes set out in this privacy policy. In doing so, we ensure transparent and proportionate processing.

If, in exceptional cases, we are unable to comply with these principles, the data processing may still be lawful because there is a justification. In particular, the following grounds for justification may apply:

- Your consent:
- the performance of a contract or pre-contractual measures the fulfillment of legal requirements;
- our legitimate interests, unless your interests prevail.

You may be required to provide us with certain personal data so that we can establish a business relationship with you. Without such data, we are normally not in a position to conclude a contract.

Under normal circumstances, the website cannot be used if certain information for securing data traffic, such as your IP address, is not disclosed.

# 2) How can you withdraw your consent?

If you have given us your consent to process your personal data for specific purposes, we will process your data within the scope of this consent, unless we have another justification.

You can revoke your consent at any time by sending an e-mail to the address given in the legal notice. Data processing that has already taken place is not affected by this.

## 3) In which cases can we pass on your data to third parties?

## a. Principle

We may need to use the services of third parties or affiliated companies and commission them to process your data (so-called processors). The categories of recipients are as follows:

- Accounting, trust and auditing companies;
- Consulting companies (legal advice, taxes, etc.);
- IT service providers (web hosting, support, cloud services, website design, etc.);

We ensure that these third parties and our affiliated companies or associations comply with the requirements of data protection and treat your personal data confidentially.

We may also be obliged to disclose your personal data to the authorities.

#### b. Visiting our social media channels

We have embedded links to our social media channels on our website. This is visible to you in each case (typically via corresponding icons). If you click on the icons, you will be redirected to our social media channels.

In this case, the social media providers find out from where you are accessing the network. The social media providers can use the data collected in this way for their own purposes. We would like to point out that we have no knowledge of the content of the transmitted data or its use by the operators.

#### c. Transfer abroad

Under certain circumstances, your personal data may be transferred to companies abroad as part of order processing. These companies are obliged to protect data to the same extent as we are. The transfer may take place worldwide.

If the level of data protection does not correspond to that in Switzerland, we carry out a prior risk assessment and contractually ensure that the same level of protection is guaranteed as in Switzerland (e.g. by means of the new standard contractual clauses of the EU Commission or other legally prescribed measures). If our risk

## 4) How long do we store your data?

We only store personal data for as long as is necessary to fulfill the individual purposes for which the data was collected.

Data that we store when you visit our website is stored for twelve months. An exception applies to analysis and tracking data, which may be stored for longer.

We store contract data for longer, as we are obliged to do so by law. In particular, we must store business communications, concluded contracts and accounting documents for up to 10 years. If we no longer need such data from you to perform the services, the data will be blocked and we will only use it for accounting and tax purposes.

## 5) How do we protect your data?

We will keep your data secure and take all reasonable steps to protect your data from loss, access, misuse or alteration.

Our contractual partners and employees who have access to your data are obliged to comply with data protection regulations. In some cases it will be necessary for us to pass on your inquiries to companies associated with us. Your data will also be treated confidentially in these cases.

Within our website, we use the SSL procedure (Secure Socket Layer) in conjunction with the highest encryption level supported by your browser.

## 6) What are your rights?

## d. Right to information

You can request information about the data we have stored about you at any time. Please send your request for information together with proof of identity to info@discgolf.ch.

You also have the right to receive your data in a commonly used file format if we process your data automatically, and if:

you have given your consent to the processing of this data;
or you have disclosed data in connection with the conclusion or execution of a contract.

We may restrict or refuse to provide information or data if this conflicts with our legal obligations, our own legitimate interests, public interests or the interests of a third party.

The processing of your request is subject to the statutory processing period of 30 days. However, we may extend this period due to a high volume of requests, for legal or technical reasons or because we require more detailed information from you. You will be informed of the extension in good time, at least in text form

#### e. Deletion and correction

You have the option of requesting the deletion or correction of your data at any time. We may reject the request if statutory provisions oblige us to store the data for a longer period or to retain it unchanged or if your request conflicts with a legal permission.

Please note that exercising your rights may be in conflict with contractual agreements and may have corresponding effects on the performance of the contract (e.g. premature termination of the contract or cost consequences).

## f. Legal action

If you are affected by the processing of personal data, you have the right to enforce your rights in court or to file a complaint with the competent supervisory authority. The competent supervisory authority in Switzerland is the Federal Data Protection and Information Commissioner: http://www.edoeb.admin.ch.

# V Individual data processing procedures

# 1) Provision of websites and creation of log files

#### a. What information do we receive and how do we use it?

When you visit www.discgolf.ch, certain data is automatically stored on our servers or on servers of services that we purchase and/or have installed for system administration, statistical, backup or tracking purposes. These are

- the name of your internet service provider;
- your IP address (under certain circumstances);
- the version of your browser software

- the operating system of the computer used to access our websites the date and time of access
- the website from which you visit one of our websites
- the search terms you used to find one of our websites.

#### b. Why is data collected?

The temporary storage of log files is absolutely necessary for the operation of the websites in order to guarantee their functionality and to ensure the security of our systems. The data is deleted at the end of each session.

## 2) Tracking pixel

We may use tracking pixels on our website. Tracking pixels are also known as web beacons. Tracking pixels - including those from third parties whose services we use - are small, usually invisible images that are automatically retrieved when you visit our website. Tracking pixels can be used to collect the same information as server log files. We use them for the same purposes as log files - you cannot prevent data collection.

## 3) Integrating content

We integrate the following content from the following providers on our website:

- Location information via Google Maps;
- Videos from Youtube.

## How does the integration work?

Location data: Your IP address is stored for the purpose of using the functions of Google Maps. This is usually transmitted to a Google server in the USA. We have no influence on this data transfer. For more information, see Google's privacy policy.

Videos: The integration takes place via a plug-in. As soon as you visit one of our pages equipped with a plug-in, a connection to the YouTube servers is established. The servers are informed which of our subpages you have visited. For more information, see Google's privacy policy[A3].

#### Why are we allowed to integrate this content?

The use of Google Maps is in the interest of an appealing presentation of our online offers and to make it easy to find the places we have indicated on the website. This is also in our legitimate interests.

We integrate content via YouTube to make our offer accessible to a wider audience. This is in our legitimate interests.

## What information do you share with the providers?

If you are logged into a user account of a provider, you may enable this provider to assign your surfing behavior directly to your personal profile. We would like to point out that we have no knowledge of the specific content of the transmitted data or its use.

If you do not want these providers to be able to associate your visit to our pages with your user account, please log out of your respective user account before using our website.

## Why are we allowed to use social media plug-ins?

We use social media plug-ins to make our website accessible to a wider audience. This is in our legitimate interests, which serve as the legal basis for data processing.

#### What information do you share with us?

We would like to point out that we have no knowledge of the content of the transmitted data or its use by the social media service.

## How can you prevent data collection?

If you do not want the social media service to be able to associate your visit to our pages with your user account, please log out of your respective user account before using our website.

You can also completely prevent the plug-ins from loading with add-ons for your browser, e.g. with the script blocker "No-Script".

## 5) Cookies

#### How do cookies work?

Our website uses cookies. Cookies are text files that are stored on the operating system of your device with the help of the browser when you visit our website. Cookies do not cause any damage to your computer and do not contain viruses.

#### What information do we receive and how do we use it?

Most of the cookies we use are so-called "session cookies". They are automatically deleted at the end of your visit.

Other cookies remain stored on your end device until you delete them. The purpose of these cookies is to store your preferences (e.g. language and location settings), to ensure that website content is provided quickly and displayed attractively (e.g. through the use of fonts and content delivery networks) and to analyze the use of this website for statistical evaluation and continuous improvement (usually using third-party cookies).

#### Why we are allowed to use cookies?

We use cookies so that we can make our website more user-friendly, effective and secure. The use of cookies and the processing of your data in this regard is based on our legitimate interests in the aforementioned purposes.

#### How can you prevent data collection via cookies?

The cookies are stored on your computer. You therefore have full control over the use of cookies. You can delete them completely or deactivate or restrict their transmission by changing the settings in your browser. If you deactivate cookies for our website, you may no longer be able to use all the functions of the website to their full extent.
